



## California Proposition 65 Statement

### To Whom It May Concern:

Proposition 65, formerly known as the “ Safe Drinking Water and Toxic Enforcement Act of 1986 “ was enacted as a California ballot initiative in November 1986. The proposition protects the state's drinking water sources from being contaminated with chemicals known to cause cancer, birth defects or other reproductive harm, and requires businesses to inform Californians about exposures to those certain chemicals.

An official list of these substances is published and periodically updated by Office of Environmental Health Hazard Assessment ( OEHHA ) for State of California. There are over 900 chemicals now on California’s list of Proposition 65 chemicals.

The Electrodyne Company, Inc is committed to providing compliant, safe and high-quality products to all of its customers. We will continue to work with our suppliers to implement a process that ensures the purchase of raw materials that will meet Proposition 65 standards.

Electrodyne does not add any substances during the manufacturing process and finished products at our facility.

Of the components used in Electrodyne’s manufacturing process some may contain slight residues or trace quantities of chemicals, identified by the state of California as known to cause cancer, birth defects or other reproductive harm. ( See Chemicals Listed Below ).

These chemicals or materials used in the formulation of the product after compounding, processing and curing creates such a small amount of exposure well below those levels to which falls into the “safe harbor” provisions of Proposition 65. Thus, poses no significant risk to the consumer.

Exposure levels are generally expressed as a daily exposure level NSRL ( No Significant Risk Levels ) or MADL ( Maximum Allowable Dose Levels ) expressed in µg/day and not as a concentration or weight percent (%) present in a product that is stated in Electrodyne’s SDS documents, Section 3, Composition/Information on Ingredients. Exposure levels are influenced by many factors, including the intended use or application for the product.

Proposition 65 does not require warning where the exposure poses no significant risk of cancer or no observable effect as set forth in law and regulations.

Electrodyne is a Manufacturer of High Energy Permanent Bonded Magnets, flexible magnets, and rigid rare earth magnets.

Products supplied by The Electrodyne Company, Inc. are Flexible Ferrite Magnets, Neodymium Iron Boron Magnets, Bonded Neodymium Iron Boron Magnets and Injection Molded Neodymium Iron Boron Magnets. These products have a physical form as a “Solid” and is insoluble in water. All are compliant with California Proposition 65, REACH and RoHS.

We define “California Proposition 65, REACH and RoHS Compliant also to mean our products contain none of the following chemicals listed below:

Lead (Pb)	Hexavalent Chromium (Cr VI)	Bis(2-Ethylhexyl) phthalate (DEHP)
Mercury (Hg)	Polybrominated Biphenyls (PBB)	Benzyl butyl phthalate (BBP),
Cadmium (Cd)	Polybrominated Diphenyl Ether (PBDE)	Dibutyl phthalate (DBP)
Diisobutyl phthalate (DIBP)	Arsenic (inorganic arsenic compounds)	

These materials are banned substances and are not added during the Electrodyne manufacturing process and finished products.

Please be advised of the following information regarding California Proposition 65 for Electrodyne Company:

By review of Safety Data Sheets and other information currently available from our suppliers, the magnets, pressure sensitive adhesives and/or over-laminates provided by Electrodyne do not contain unacceptable levels of any chemicals on the current Proposition 65 chemical list.

Since the Proposition 65 chemical list is dynamic and changes frequently, we will monitor it closely to ensure Compliance. This statement will be updated and Proposition 65 warning labels will be affixed to our products if/when any of our product contents or production practices deem it necessary.

Because we cannot test every piece of every order that we ship to our customers for every one of the California Proposition 65 listed 900 plus chemicals. We therefore inform our customers of the presence of Proposition 65 Listed Chemicals, so that they may make their own risk assessments.
